

Editorial Note

This issue completes Volume XIII of the *Philippine Sociological Review*. In a continuing effort to make the *Review* self-supporting, we have during the past few months been soliciting ads and conducting a program for Patron or Institutional Memberships. The latter involves payment of P50.00 per year to the Philippine Sociological Society and entitles the holder to 5 copies of the *Philippine Sociological Review* and to send delegates to the regular meetings and conventions of the Society.

The Third National Convention of the Philippine Sociological Society will be held at the NSDB Pavilion, Manila from May 12-15, 1966. The National Science Development Board is co-sponsoring the Convention. The theme of this year's convention is *Research and Institutional Planning*. Mr. Salvador Parco of the PACD and the Ateneo de Manila University and Dr. Agaton Pal, President of the Visayas-Mindanao Chapter, have been designated as co-chairmen.

The Convention program has tentatively been divided into the following sections: Family, Religion, Education, Economy, Health and Welfare, Politics and Communications. The response to date from social scientists in different agencies and institutions has been encouraging. Those wishing to submit papers for delivery at the Convention are encouraged to contact Dr. Mercedes B. Concepcion, Chairman of the Program Committee.

We welcome any suggestions regarding the forthcoming Convention.
